OVERVIEW

MEF 3.0 LSO Sonata Certification enables buyers and sellers of wholesale connectivity services to validate that their suite of APIs used for inter-provider business transactions conform to MEF standards. Tested and certified LSO Sonata APIs are a combination of four elements:

- Buyer or seller
- LSO Sonata release
- Business function
- Product payload

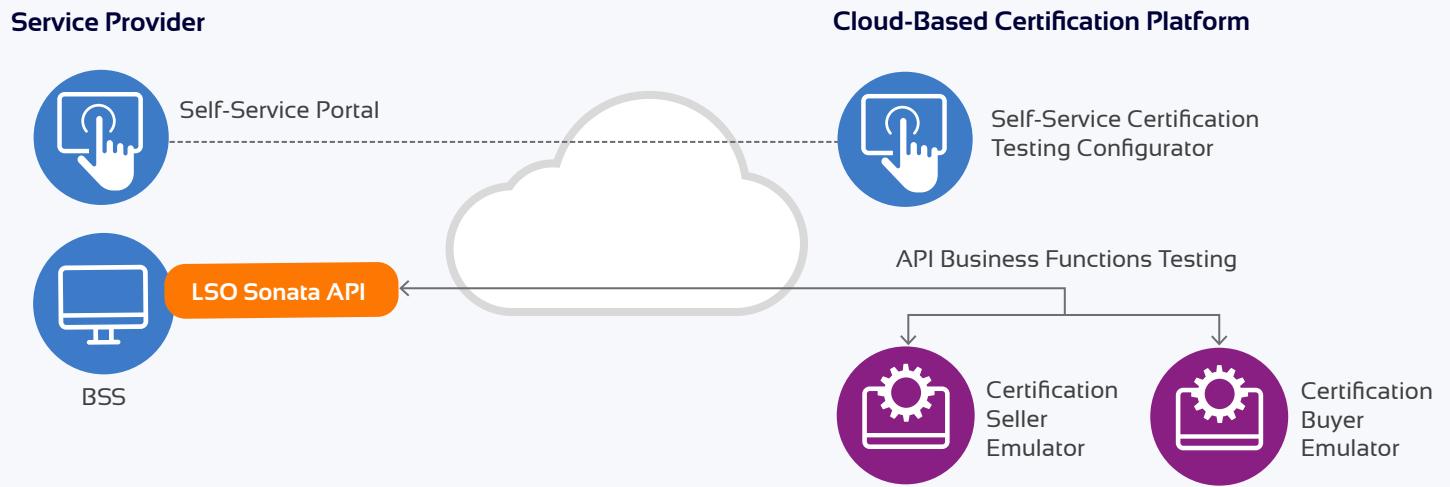


MEF LSO Sonata Certification—At a Glance

- On-demand, intuitive, self-service certification via Iometrix's (MEF-Authorized Test and Certification Partner) cloud-based test platform
- Test cases are based on MEF W92.1 LSO Sonata Test Requirements draft standard
- Dynamically-created buyer and seller emulators generate the mandatory test cases against service provider-specific implementations
- Test platform is available to developers for up to 6 months prior to the final certification test run
- Business functions (e.g., product order) can be certified individually or in combination with volume discounts
- Platform provides positive and negative test cases, with extensive debug and error messaging
- Company certification is displayed in the MEF LSO API registry
